Born and raised in Congressional District 18, Christina Morales has been a leader in the community her entire life. She runs her small business family funeral home, the Felix H. Morales Funeral Home, and serves as Texas House Representative for District 145. Her family has a legacy of community service, including the Annual Morales Back to School Supplies giveaway that Christina started in 1997. Now in its 27th year, the supply giveaway ensures that over 2,000 kids in CD18 have the supplies they need to start each school year strong. In addition to the school supply giveaway, Christina hosts an annual Death by Chocolate community fundraiser, an annual College and Career Day connecting high school students with universities, colleges, resources, and local community partners, and she hosts multiple food distributions within the community every year.

Currently representing part of CD18 in the Texas House, Christina Morales knows what the community needs. Determined to expand her commitment to the community where she was raised, Christina successfully ran for State Representative in House District 145 in 2019. She is proud to represent her community and a portion of CD18 in the Texas House. Continually garnering praise from her colleagues for her exceptional constituent engagement, she is also a fighter in Austin. During the 88th Legislative Session, she authored and voted for bills supporting public education, worked to expand access to Ethnic Studies across the state, and fought Republican attacks on immigrants, voting rights, and women's healthcare. She has served as the Vice-Chair of the International Relations and Economic Development Committee and is currently the highest elected member of the Mexican American Legislative Caucus serving as the Vice-Chair.

Christina is blessed with two children and twin grandsons. She currently serves as President, CEO, and Funeral Director of Morales Funeral Home and President of the Morales Memorial Foundation located in Congressional District 18.

Notable Achievements in the Texas House

- Authored the first Ethnic Studies bill to ever pass in the Texas House of Representatives

- Passed a bill that requires additional active shooter training for peace officers, including school district peace officers and school resource officers to better protect students
- Organized a House Committee Meeting of State Leaders to collect testimony on the board of managers and current superintendent at HISD
- Stood up for Texas Voters in 2021 and was a leading voice in the 38-day quorum break to block republicans from passing hateful voter restriction laws
- Continually stood on the back microphone to block and kills harmful republican bills on open carry, anti-abortion, voter suppression, anti-DEI, and anti-immigrant legislation

Family History in CD18

When Representative Christina Morales' grandparents, Felix H. and Angela V. Morales, came to Houston in 1931, they began a family tradition of community-building. At the time, few funeral homes in Houston offered dignified burials to Latino families. They established Morales Funeral Home in 1931 and founded KLV La Voz Latina, the first Spanish-language radio station to broadcast news for the Gulf Coast, in 1946. It is from this upbringing that Christina learned to view the community as her family and build on the work that her grandparents began.

At age 23, following the death of her grandmother, Christina assumed ownership of Morales Funeral Home. She would continue to uphold its reputation for excellent service, forming long-lasting bonds with the families she consoled in their darkest hour. Under Christina's leadership, Morales Funeral Home has become a Houston institution and a pillar of the Second Ward community.

In 1997, Christina built on her grandparents' legacy of community engagement by establishing the Annual Morales Back to School Supplies Giveaway. Twenty-four years later, the program continues to serve more than 2,000 students each year, providing school supplies to families in Houston's most underprivileged communities.

The Morales Memorial Foundation and Felix H. Morales Funeral Home continue to give back to the community through community events, scholarships, and fundraising.
